2. Pending issue of guidelines on the above grant-in-aid, State Governments are advised to utilize the first installment of 2010-11 in conformity with the recommendations of the Thirteenth Finance Commission contained in paras 10.141 to 10.167 of the report (Vol.I). The guidelines which were issued by the Government of India would cover the above releases as well.
3. States have to transfer above amounts to local bodies within 15 days of receipt from the Government of India. For any delay beyond 15 days, States have to pay penal interest at the RBI bank rate to local bodies for the delayed period along with the instalment.
4. You are requested to advise Reserve Bank of India, Nagpur to credit the above amounts to the accounts of the respective State Governments.
5. The above amount will be subject to adjustment against the amount of grant to be released through the issue of Presidential Order during the course of the year.
6. The payments are adjustable in the accounts of the Ministry of Finance under the Major Head 3601.01.104.05.00.31 Grants-in-aid to states for Local Bodies Grants in Demand No.35 – Transfers to State and Union Territory Governments for 2010-11.
