Sub: Proposal for submission of Budget provision for 2010-11 against the fund allocated
under the award of Third Assam State Finance Commission (TASFC).

Sir,


With reference to the subject cited above, I am directed to say that TASFC recommended Rs.98496.00 lakh for 2010-11 for devolution of fund to local bodies under general areas. State Finance Commission Cell under Finance (Economic Affairs) Department will make budget provision of Rs.98496.00 lakh for rural Local Bodies and Urban local bodies for 2010-11 as per Technical Supplement of the TASFC for general areas. The whole amount includes salary and non-salary component for each unit of the Local Bodies. The Administrative Departments may bifurcate the amount of salary and non-salary component during year 2010 -11 on basis of the devolution to each tier of Local Bodies in alphabetical order as per format LSGI-I which has already been circulated to all Local Self Government Institution (LSGI) and administrative Department.

The entire recommended amount for 2010-11 is untied funds for PRIs and U.Bs. As such, the department may quantify the requirement of funds for salary component first and after that they may segregate the requirement of funds for non-salary components for expenditure on establishment, repair and rejuvenation of water supply and sanitation projects, repair of local roads and other public assets, solid waste management schemes and any other locally felt needs.

I am, therefore, to request you to kindly furnish budget provision for salary and non-salary component separately as per format LSGI -I for each unit of the LSGIs in alphabetic order. The Administrative Department is also required to send the L Statement in case of the salary component as per instruction of Finance (Budget) Department. SFC Cell has already uploaded the Report of the TASFC in the Website <http://www.sfcassam.nic.in>.

This may treated as MOST URGENT.


