

They will nominate nodal officers under award of 13th Finance Commission for submission of UC and others papers.

In view of above, SFC Cell under Finance (EA) Department will review with concerned Directors / Nodal Officers in respect of utilization of fund of 13th FC award from time to time. The concerned head of Department or nodal officer will coordinate with SFC cell to report utilization of fund under 13th FC in respect of Local Bodies. The SFC Cell under Finance (Economic Affairs) will report the progress of utilization to the Principal Secretary, Finance Department


